Welcome to our newest NCSA members, Constance Marie Morris and Trisha Toler!

What is Quality Assurance Review (QAR) and why is it important to you and NCSA?

With the identifying information blacked out, our QAR committee looks at the statements for presentation and consistency, principles of accounting, and correct titles. The process will help to increase your confidence that your presentations are in accordance with accepted professional standards.

Earlier in my year as President, I conducted a survey on QAR. Following are answers to some of the questions you asked:

- 1) At this time, there is no additional cost for this service. It is one of your membership benefits.
- 2) Your information is mailed to the committee. No one physically comes to your office.
- 3) The reviewers are offering assistance, not criticism.
- 4) Even though most people outside the accounting arena do not know what QAR is, you will be presenting a high quality product on behalf of your client. Some of the pointers possibly could protect you from a lawsuit.
- 5) QAR does not stand for "Queen Anne's Revenge."

NC CPAs who are in the public practice of accountancy are subject to mandatory peer review every three years. Even though the review of our financials is not mandatory, our members are required to prepare financial statements using the same principles and standards.

There are many changes in the accounting profession today. Other states across the country have recently been fighting to protect their rights. Only four states enjoy the right to practice accounting as freely as we do in NC. Since last July, 123 of our members have attended a QAR CPE presentation by QAR Chair David Hooker. Most of you are aware of NCSA's continuing monitoring of legislation in order to maintain our right to practice as accountants in North Carolina. Our internal review of financial statements and preparation of high quality financial statements will enhance our position in proving our members are capable and informed. The more member participation we have in the program enhances our power to maintain our current right to practice.

One member said to me, "QAR makes you a better accountant." Do you agree?

Tax Recovery Program

The NC Department of Revenue recently launched the Trust Tax Recovery Program which helps businesses recover from certain tax liabilities. It will offer penalty and fee waivers as well as payment plans to companies that have liabilities for sales, withholding, and other trust taxes.

Businesses that file and pay all outstanding taxes within the payment plan terms may have their penalties and collections fees waived. Fees and penalties may be reinstated if program participants fail to file or pay future taxes as required.

Sales & Use Tax

As of April 1, Harnett County's local sales and use tax goes up by 0.25% raising it to 2.25%. As of that date, the effective sales and use tax for state and local use is 6.75% in 73 counties; 7% in Alexander, Buncombe, Cabarrus, Catawba, Cumberland, Duplin, Edgecombe, Greene, Halifax, Harnett, Haywood, Hertford, Lee, Martin, Montgomery, New Hanover, Onslow, Pitt, Randolph, Robeson, Rowan, Sampson, Surry, and Wilkes Counties; 7.25% in Mecklenburg County; and 7.5% in Durham and Orange Counties.

The sales price of a service contract sourced in NC and sold at retail to maintain or repair a motor vehicle is subject to the state tax rate of 4.75% plus applicable local and transit rates. The sales price of any such service is *not* part of the gross receipts derived from the lease or rental of a motor vehicle or a part of the retail value of a motor vehicle.

A 3% highway use tax is imposed on the retail value of a motor vehicle for which a certificate of title is issued. The highway use tax is payable to the NC Division of Motor Vehicles at the time of application for a certificate of title. A retailer may elect not to pay this tax when applying for a certificate of title for a motor vehicle purchased by the retailer for lease or rental. A retailer who makes this election must pay a tax on the gross receipts of the lease or rental of the vehicle. For a short term lease, the rate is 8%; the tax rate is 3% of the gross receipts derived from the lease. The motor vehicle lease tax on the gross receipts derived from a lease or rental is payable to the NC DOR.

Tax Fraud

If you suspect someone stole your identity and used your SSN for employment purposes or could use your SSN to file a tax return, complete Form 14039 on-line, print it, and mail or fax to the appropriate office using the options on page 2 of the form; include photocopies of at least one of the documents listed on the form to verify your identity.

If you suspect fraudulent activity or an abusive tax scheme by a tax return preparer or tax presentation company, complete Form 14157 on-line, print it, and mail it to the IRS address on the form.

If you suspect a tax return preparer filed a return or altered your return without your consent and you are seeking a change to your IRS account, send Forms 14157 and 14157-A to the address shown on the instructions for Form 14157-A.

If you suspect an abusive tax promotion or promoter, mail or fax Form 14242 to the IRS address or fax number on the form.

If you suspect misconduct or wrongful doing by an exempt organization or employee plan, mail Form 13909 to the address provided on the form.

If you have information and want to claim a reward, mail Form 211 to the address in the instructions.

For reasons other than the above and you suspect or know of an individual or business that is not complying with the tax laws on issues such as false exemptions or deductions, kickbacks, false/altered document, failure to pay tax, unreported income, organized crime, or failure to withhold, print and mail Form 3949-A to IRS, Fresno, CA 93888.

IRS2Go

The IRS announced the release of IRS2Go 4.0, an update to its smartphone application featuring new, added features available both in English and Spanish.

The redesigned IRS2Go provides new features for taxpayers to access the latest information to help them in the preparation of their tax returns. In this version, IRS2Go highlights the addition of an innovative new refund status tracker, providing taxpayers an easy-to-use feature to follow their tax return throughout the process.

Publication 1345, *Handbook for Authorized IRS e-file Providers of Individual Income Tax Returns*, has been revised and updated. It now is available in Web content, but not downloadable pdf version [when we need it most]. This publication provides important information for tax professionals and authorized *e-file* providers regarding applying and participating in IRS *e-file*. All participants should read this publication to become familiar with the requirements for continued participation.
